FFY 2026-2029 Transportation Improvement Program (TIP) Amendments

Three amendments are proposed to add projects recently approved by the INCOG Board to the FFY2026 Transportation Improvement Program. The projects are being funded with Congestion Mitigation and Air Quality funds allocated to INCOG and include wayfinding signage on City of Tulsa and City of Broken Arrow regional trials and technology upgrades at the City of Tulsa Traffic Operations Center. A summary of the TIP amendments is included in the agenda packet.

- 6. Approval of Community Expansion of Nutrition Assistance (CENA) Grant Awards**
As part of the INCOG Area Agency on Aging (IAAA) program, INCOG annually receives state funding through the Oklahoma Department of Commerce (ODOC) for the CENA program. CENA funds are used by Senior centers for non-Title III related expenses such as equipment, facility improvements, non-personnel operating expenses and ADA improvements. Independent centers can also receive funds for food costs. Following a call for projects, the INCOG Board approved funding for fourteen projects in the amount of \$137,861 at the August 12, 2025 Board meeting. At that time there was still an unallocated balance of \$88,250.40 in funding available. In response to a subsequent call for projects the Tri-County Council on Aging Resource Allocation Committee is recommending approval of an additional nine projects for \$88,007. A summary of the projects previously recommended and additional recommended projects is included in the agenda packet. The Board is asked to approve the additional projects recommended by the Resource Allocation Committee and authorize execution of necessary contracts.
