# 4. Air Quality Update

The Oklahoma Department of Environmental Quality- Air Quality Division has broad responsibility for an array of services including air monitoring, permits and emissions inventories in Oklahoma. A representative of the ODEQ will brief the Board on the conclusion of the 2024 Ozone season, the timeframe for the review of the National Ambient Air Quality Standard for ozone by the Environmental Protection Agency, and the outlook ahead for air quality issues in Oklahoma.

# 5. Opioid Abatement Update

The Oklahoma Opioid Abatement Board was created to promote and protect the health of Oklahomans by using monetary grants to abate the opioid crisis in a comprehensive manner that includes cooperation and collaboration with political subdivisions. The Board earlier this year awarded grants to numerous cities, counties, school districts and public trusts in Oklahoma to help address the opioid crisis. A second round of funding is expected to open in January 2025. In addition, a direct allocation of funding is available to 15 cities and 24 counties that are non-litigating political subdivisions. An update on the current status of the programs and initiatives will be provided by Carol Bush, a member of the Oklahoma Abatement Board and Terry Simonson, Special Counsel for the Attorney General.

# 6. Payroll Services

The City of Tulsa, earlier this year, notified INCOG and the River Parks Authority it would no longer provide payroll services to the agencies after December 31,2024. As a result, INCOG has solicited proposals from various payroll service providers to provide payroll services beginning January 1, 2025. After a review of proposals from various vendors, it is recommended that INCOG engage Paychex Inc. to provide payroll services for INCOG beginning January 1, 2025. The Paychex pricing model provides for a one-time implementation fee, and annual, monthly and pay period fees based on number of employees. Based on the Paychex quote, the anticipated annual cost will be less than \$5,500 annually. It is recommended that the Board approve Paychex as our payroll services provider.

The board will be asked to adopt the 2025 regular meeting schedule. A copy of the schedule is included with the agenda packet.

# 8. Approval of Updated INCOG Position Classification and Salary Schedule

The INCOG Board of Directors approved the current INCOG Position Classification and Salary Schedule in December 2021 upon the recommendation of the Executive Committee based on a compensation study completed by Graves Consulting, Inc. An update to the Position Classification and Salary Schedule has been developed by Graves Consulting to reflect changes since that time in market compensation. The INCOG Executive Committee met on August 13, 2024, reviewed the update schedule and recommended its approval by the Board of Directors. A copy of the updated schedule is attached to the agenda packet. The Board is asked to approve the Classification and Salary Schedule.
